PROTOCOL FOR THE SAFETY OF INTERNATIONAL VISITORS AND GUESTS

AT THE UNIVERSITY OF MILANO-BICOCCA

The provisions set out in this document apply to all international visitors and guests (professors, researchers, research fellows, fellows, students, graduate students, post-doc, administrative, technical and other staff) coming from foreign countries to carry out study activities and / or research at the University of Milano-Bicocca, for more or less prolonged periods.

GENERAL PROVISIONS

The situation brought about by the Covid-19 pandemic is constantly evolving. Each guest and international visitor is required to stay informed about the directives in force, with reference to the measures enacted at the national, regional and local level.

At the national level, the procedures for moving from abroad to Italy are regulated, and further measures may be applied in relation to provenance from specific foreign states and territories

Groups of countries have been identified, for which particular limitations are envisaged, which may in any case further vary over time, depending on the evolution of the pandemic. All updates are published at the ministerial link mentioned here.

Before leaving for Italy, you should check any additional provisions imposed by the Lombardy Region on travelers from abroad (<u>https://www.regione.lombardia.it/wps/portal/istituzionale/</u>).

The possibility of moving between different Italian regions must always be checked. We remind all international visitors and guests of the need to take out adequate personal health insurance to protect their health and cover the risks due to the health emergency.

SPECIFIC PROVISIONS

For all, the methods and rules of access to the buildings and laboratories of the University of Milano-Bicocca remain. The rules of conduct for staying in the University facilities require compliance with the regulations of hygiene and behaviour prescribed for containing the spread of the infection, already published on our website at the link https://www.unimib.it/ateneo/covid-19-istruzioni-sicurezza.

Any transgression of local and national laws will entail immediate expulsion from the University and, in the case of international students on incoming mobility, the request to the home university to apply disciplinary sanctioning measures.

The university residences of the University of Milano-Bicocca guarantee all safety measures for the containment of the infection in agreement with the University Health Services and offer support measures in the presence of a new lock-down and / or isolation.

If you are diagnosed positive for COVID-19 in the days following your presence at the University, you must promptly report it by writing to <u>medico.competente@unimib.it</u> indicating your telephone contact in the e-mail.

UNIVERSITALY

The visa application process for entry into Italy for study purposes, where necessary, is available through the Universitaly portal, which allows the online submission of pre-enrollment applications for international students and request for visas. This helps reduce costs and travel times in reaching consular offices to present the documentation and reduces attendance at Italian consular offices abroad.

All enrollment procedures are carried out entirely online in the management system of the University of Milano-Bicocca and the delivery of the documents necessary for enrollment for all courses is postponed to 31 December 2020 (DR No. 0035362/20 of 16 June 2020). The ministerial provision applies according to which failure to obtain a visa entails the forfeiture of enrollment at an Italian university.
