THIRD MISSION EXPERIENCE

Some of the above-mentioned research projects provided me with the opportunity of third mission activities. For instance:

"FDI and Internalisation in East Asia: Evidence from Italy and Spain". The primary output of this research project was an original firm-level database covering 90% of Italian and Spanish multinationals with affiliates in China. In-depth interviews, based on a multiple-choice questionnaire, allowed collecting detailed survey data that were employed for econometric purposes in papers 13, 15, 19, 20, 21, 29, and 30 (see the above list), previously presented at conferences and invited seminars in Seville (2006), Munich (2006), Bocconi University (2006), University of Milano (2006), Seoul (2003), London (2003) (see the above list).

Furthermore, I was in charge of organizing the conference "Cina: la parola ai protagonisti", hold in Bocconi University in 2006, and involving about 100 Italian entreprenueurs and managers. In this context, fund raising activities were managed as well.

"Chinese FDI in Italy: Mapping out and Explaining a New Trend". This study took the opposite perspective, compared with the above-mentioned because it investigated Chinese FDI in Italy, rather than Italian FDI in China. The primary output of this research project was an original firm-level database covering the entire population of Chinese multinationals with affiliates in Italy. These data have been exploited for both academic and non-academic purposes. With respect to the former, see papers 8, 10, 11, 14, 25 and 26 (see the above list) previously presented at conferences and invited seminars in Oxford (2010), Venezia (2010), and Bergamo (2011) (see the above list).
